Students pursuing a double major must meet the graduation requirements of the department (institute, degree program) they are adding, based on the graduation conditions for the academic year in which they were approved to pursue the double major. In addition to fulfilling the required credits for their primary department (institute, degree program), students must complete all required professional courses for the additional department (institute, degree program) in order to qualify for a double major.
