1.依本校雙主修辦法第6條:「以核准修讀學年度的畢業條件為基準」,請自行查閱本系該學年度畢業條件 所列需修習課程,並於取得學位前一年自行與系辦確認是否符合資格,並進行補救,若無確認造成無法取 得學位者,需自行負責。

- 2.依母法須修習**必修**課程學分,雙主修不足40學分、輔系不足20學分者,方可修習選修學分。不清楚以上規定者請務必向財金系辦確認!
- 3.計入本系輔系20學分、雙主修40學分之課程,必需是課程代碼 U21,財金系所開課程。除非是「院課程」或本系所承認外系之專業選修例外。

According to Article 6 of the Double Major Regulations at this university: "Based on the graduation requirements for the academic year of approved study," please refer to the courses listed for that academic year's graduation requirements in our department, and confirm with the department office one year before graduation whether you meet the criteria. If no confirmation is made, resulting in ineligibility for graduation, you will be responsible for the consequences.

According to university regulations, required course credits must be fulfilled. For students pursuing a double major with less than 40 credits or a minor with less than 20 credits, elective credits may be taken. If unsure about these regulations, please confirm with the Department of Finance office!

Courses counting towards a minor (20 credits) or double major (40 credits) in this department must have a course code of U21, which are courses offered by the Department of Finance. Exceptions include only "College Courses" or professional electives recognized by the department from other departments.
